SUMMARY OF OFFERING

What are we offering?

Offering:	Units of the Company (each, a " Unit "), comprised of one common share in the capital of the Company (each, a " Common Share ") and one Common Share purchase warrant (each, a " Warrant "). Each Warrant is exercisable into one Common Share at a price of \$0.70 per Common Share for a period of 60 months from the date of issuance.
Offering Price:	\$0.50 per Unit.
Offering Amount:	A minimum of 4,000,000 Units and a maximum of 10,000,000 Units, for minimum gross proceeds of \$2,000,000 and maximum gross proceeds of \$5,000,000 (the " Offering ").
Closing Date:	The closing of the Offering is expected to take place on June 11, 2026, but may take place in one or more tranches, provided that the final tranche closing will occur no later than July 9, 2026, being 45 days following the date hereof.

Description of Common Shares	The holders of Common Shares are entitled to: (i) receive dividends as and when declared by the board of directors of the Company, out of the moneys properly applicable to the payment of dividends, in such amount and in such form as the board of directors may from time to time determine; (ii) in the event of the dissolution, liquidation or winding-up of the Company, whether voluntary or involuntary, or any other distribution of the assets of the Company among its shareholders for the purpose of winding-up its affairs, receive the remaining property and assets of the Company; and (iii) receive notice of and to attend all meetings of the shareholders of the Company and to have one vote for each Common Share held at all meetings of the shareholders of the Company, except for meetings at which only holders of another specified class or series of common shares of the Company are entitled to vote separately as a class or series.
Description of Warrants	Each Warrant will entitle the holder thereof to acquire, subject to adjustment in certain circumstances, one Common Share at an exercise price of \$0.70 until 5:00 p.m. (Toronto time) on the date that is 60 months following the date of closing, after which time the Warrants will be void and of no value. The Warrants will be governed by the terms and conditions set out in the certificate representing the Warrants (the "Warrant Certificates") delivered at the closing of the Offering. The Warrant Certificates will provide for adjustment in the number of Common Shares issuable upon the exercise of the Warrants and/or the exercise price per Common Share upon the occurrence of certain customary events. No fractional Common Shares will be issuable to any holder of Warrants upon the exercise thereof, and no cash or other consideration will be paid in lieu of fractional Common Shares. SUMMARY DESCRIPTION OF BUSINESS

What is our business?

MustGrow is a provider of innovative biological and regenerative agriculture solutions designed to support sustainable farming. The Company's proprietary products and technologies offer eco-friendly alternatives to restricted or banned synthetic chemicals and fertilizers. These products and technologies are derived from mustard seed and developed into organic biocontrol and biofertility products to help replace or reduce the use of banned or restricted synthetic chemicals and fertilizers, and protect soil health and the soil microbiome, support plant health, and contribute to global food security through more sustainable agricultural practices. In North America, MustGrow owns and is working on product registrations and sales. The Company's first registered product, TerraSante™, a biofertility product, launched in 2024 and is currently registered in key U.S. states and initial sales ramp-up is ongoing. Outside of North America, MustGrow is focused on collaborating with agriculture companies, such as Bayer in Europe, the Middle East and Africa, to commercialize MustGrow's wholly-owned proprietary products and technologies. The Company is dedicated to driving shareholder value through the commercialization and expansion of its intellectual property portfolio of 108 patents that are currently issued and pending.

MustGrow's biocontrol technologies include biopesticides, biofumigants and bioherbicides derived from mustard seed. The mustard plant, which is a Brassica species plant, has natural compounds within it that produce natural chemicals with pesticidal, fungicidal and herbicidal properties. Allyl-isothiocyanate and thiocyanate are the active ingredient compounds that are part of the plant's defense mechanism against disease, pests and weeds. MustGrow has extracted the natural molecules that form these natural compounds from mustard seed and formulated them in dry and liquid forms, with potential for use as a commercial biopesticide, biofumigant and bioherbicide. MustGrow owns issued patents, patent applications, trade secrets and know-how covering the extraction, formulation and use of these natural compounds. MustGrow's biocontrol technology is a platform technology with multiple applications, including preplant soil treatment of disease, pests and weeds, and a biologic for postharvest food preservation. In December 2023, the Company entered into an exclusive license and collaboration agreement with Bayer covering soil applications of MustGrow's mustard-based biocontrol technologies in Europe, Middle East and Africa, excluding home and garden, turf and ornamental applications.

The Company has developed an organic mustard-based soil amendment and biofertility technology containing nutritious plant proteins and carbohydrates that feed soil microbes to potentially improve beneficial microbial activity and ensure long-term sustainable soil health. These targeted micro-communities are shown to improve nutrient availability, which can improve crop nutrient uptake, increase

plant vigor and yields, while reducing plant stress. Under the brand name TerraSante™, the Company has OMRI Listed® organic certification in the U.S. and product registrations in the states of California, Washington State, Oregon, Idaho, Arizona, Florida Georgia, Texas, Utah and Montana. The Company commenced production and sales of TerraSante™ in 2024.

Recent Developments

On August 29, 2025, the Company announced: (i) the closing of its a non-brokered private placement of 3,059,731 units of the Company (each, an "**August 2025 Unit**") at a price of \$0.70 per August 2025 Unit for gross proceeds of approximately \$2,141,812 (the "**August 2025 LIFE Offering**"); (ii) the repricing of, and amendment to, an aggregate of 1,721,610 outstanding Common Share purchase warrants; and (iii) the issuance of an aggregate of approximately 3,407,134 Common Shares as settlement for debt to certain holders of unsecured convertible debentures with an aggregate principle of \$2,385,000 issued pursuant to its non-brokered private placement of units closed in January 2025.

On September 10, 2025, the Company announced that it had secured a \$2,000,000 line of credit (the "**LOC**") with Canadian Imperial Bank of Commerce, guaranteed by Export Development Canada. The LOC carries an interest rate linked to Canada's prime rate plus 1.00%, per annum.

On December 10, 2025, the Company announced that it had positive U.S. potato yield and economic performance in large-scale field trials utilizing their TerraSante™ in Washington State and Idaho.

On January 8, 2026, the Company announced is a non-brokered private placement of up to 4,000,000 units of the Company (each, a "**January 2026 Unit**") at a price of \$0.50 per January 2026 Unit for gross proceeds to the Company of up to \$2,000,000 (the "**January 2026 LIFE Offering**"). Each January 2026 Unit consisted of (i) one Common Share; and (ii) one Common Share purchase warrant (each, a "**January 2026 Warrant**"). Each January 2026 Warrant is exercisable for a period of 60 months from the date of issuance and entitles the holder thereof to purchase one additional Common Share at an exercise price of \$0.70 per Common Share.

On January 23, 2026, the Company announced closing of the January 2026 LIFE Offering for aggregate gross proceeds to the Company of \$2,000,000.

On February 3, 2026, the Company announced completion and results of its 2-year field trial program in the Canadian Prairies on approximately 100 acres of canola production. Field trial findings have demonstrated MustGrow's TerraMG™ is a sustainable technology capable of suppressing clubroot parasitic disease (*P. brassicae*) and promoting higher canola yields and root systems under various disease pressures.

On March 31, 2026, the Company announced it is closing its wholly-owned Canadian marketing and distribution business NexusBioAg effective April 15, 2026. NexusBioAg had been re-selling and distributing third party products to Canadian farmers, a lower-margin and price-competitive business. Remaining inventory was to sold in subsequent months through existing distribution channels. Instead, MustGrow announced its focus of its capital and resources on scaling inventory to meet accelerating demand for its mustard-derived organic biofertility product TerraSante™ in the U.S.

On April 28, 2026, the Company announced receipt of the Georgia Department of Agriculture registration approval for its mustard plant-based TerraSante™. The Georgia organic certification is included under MustGrow's existing Organic OMRI Listed® certifications in Florida, Arizona, Idaho, Oregon, and Washington State.

On April 29, 2026, the Company announced its 2025 financial year end results, including increased sales revenue of \$8.3 million in 2025, up from \$0.4 million in 2024, net losses of \$7.3M in 2025, up from \$4.9M in 2024, and TerraSante™ biofertility sales in the U.S. were \$0.6 million in 2025, up 377% from 2024 when U.S. sales were just over \$0.1 million.

On May 14, 2026, the Company announced entering into a media services agreement with Market One Media Group Inc. dated January 13, 2026, a paid for market research agreement with GBC AG dated January 28, 2026 for German and European investors.

On May 25, 2026, the Company announced receipt of registration approvals from the Texas Department of Agriculture, the Utah Department of Agriculture and Food, and the Montana Department of Agriculture for its mustard plant-based TerraSante™.
